## **GERONIMO ENERGY – SOLAR GARDEN SUBSCRIPTION PROGRAM**

Lee Bjerk of Geronimo Energy presented information on the Xcel Energy Solar Garden Subscription Program. This program would allow Pipestone County to subscribe to a solar garden and receive a production credit on each bill to offset energy costs. Estimated savings for the County is \$10,074.00 for the first year and \$237,302.65 over the course of the 25-year contract. For the Pipestone County Medical Center, the average savings is \$28,500.00 in the first year and \$672,300 over the life of the 25-year contract. The Board showed a strong interest in the program, but has one other company that would like to present on a solar garden subscription program located in Lincoln County. Consensus of the Board to take action on this request after they have listened to the presentation from the other company.
