# STEVE BEEKMAN AND ANN ORREN- ALCOHOL PREVENTION COORDINATOR

Steve Beekman introduced himself to Commissioners as the new Alcohol Prevention Coordinator hired by Southwest Health and Human Services (SWHHS). Beekman and Ann Orren, SWHHS Community Public Health Supervisor, reviewed the program and discussed program initiatives. SWHHS received a grant of \$945,000 for administration of the program for a period of five (5) years.

# WAYNE DREW - FAIRGROUNDS BUILDING UPDATE

Building and Grounds Maintenance Supervisor Wayne Drew reported to the Board that he has received one quote for the construction of a new Beef and Dairy barn at the County Fairgrounds. Discussion took place on the design of the building and expected cost. Supervisor Drew plans to receive two more quotes on the construction of the building and will bring back to the Board for final approval.

#### ASSESSOR REAPPOINTMENT

Assessor Joyce Schmidt joined the meeting. Minnesota Statutes 273.061 declares that the terms of office as County Assessor shall begin on January 1 of every fourth year after 1973.

January 1, 2017 will begin a new term of office for Assessors statewide. Motion by Wildermuth, seconded by Nath to approve the re-appointment of Joyce Schmidt as County Assessor for a period of four years beginning January 1, 2017. Motion carried unanimously.

# 2017 HEALTH INSURANCE RECOMMENDATIONS

Kozlowski Insurance representative Jerry Brockberg and Human Resources Coordinator

Cathy Feste joined the meeting to discuss 2017 health insurance for Pipestone County

employees. Brockberg reviewed Pipestone County's claims history, calculated premium

increase and the Insurance Committee's recommendation on which plans to offer. Motion by Remund, seconded by Nath to accept the Insurance Committee's plan recommendations and offer the 1500 CMM, 3250 HSA/VEBA, 4000 HSA/VEBA, and 6350 HSA/VEBA as health plan options in 2017. Motion carried unanimously.

Human Resources Coordinator Cathy Feste reviewed contribution recommendations put forth by the Insurance Committee. Consensus of the Board to review the recommendations in more detail and consider options for approval at the October 25, 2016 Commissioner Meeting.

HR Coordinator Feste also presented for approval a Letter of Agreement for Wellness Institute Services between the SWWC Service Cooperative and Pipestone County in which Pipestone County agrees to participate in the Wellness Program offered by the Wellness Institute in 2017.
