# LAKE BENTON II ROAD USE AND DEVELOPMENT AGREEMENTS

Danell Herzig, Kimberly Dickey, and Joe Gallagher of Lake Benton Power Partners II, LLC and Jay Wetmore of Westwood Inc. joined the meeting. A presentation was made on the Decommissioning Plan for the current site as well as the Development Agreement and Road Use Agreement. Motion by Kooiman, seconded by Nath to approve the Road Use and Repair Agreement between Lake Benton Power Partners II, LLC and Pipestone County. Motion carried unanimously.

Motion by Johnson, seconded by Wildermuth to approve the Development Agreement effective March 5, 2019 between Lake Benton Power Partners II, LLC ("Owner") and

Pipestone County, Minnesota ("County"). The agreement states the following:

1. The Owner desires and intends to develop an approximately 100 megawatt ("MW") large wind energy conversion system in Pipestone County, Minnesota (the "Project"). The Project Area includes the following:

Table 1: Project Area Location

- 2. Depending on the final turbine selected by the Owner, the wind energy facility will consist of up to 44 wind turbines and each turbine will generate between 2.1 and 2.3 MW. At completion, the wind farm will generate approximately 100 MW of electrical energy.
- 3. The Owner has applied for a site permit for a large wind energy conversion system from the Minnesota Public Utilities Commission ("MPUC") pursuant to Minnesota Statutes Chapters 216F. The rules implementing these LWECS permitting requirements are found in Minnesota Rules Chapter 7854.
- 4. Electricity from the Project will be transported via an underground collection system to the three existing substations and the new Golf substation where it will be stepped up to 115 kV and then interconnected to Northern States Power Company's 115 kV distribution lines.
- 5. The Owner entered into agreements with the owners of the real property within the Project Area, giving it control of this land for the purpose of, and authority to, develop the Project.
- 6. This Agreement specifies the commitments made by the Parties for the purpose of ensuring that the Project is consistent with the County's existing applicable policies and ordinances, and to ensure that all final approvals will be in the best interests of area citizens.

Motion carried unanimously. This agreement is effective for 5 years from the date of approval.

County Administrator Steve Ewing presented a quartzite stone agreement which states that the County of Pipestone and City of Pipestone wish to salvage and store for future use a quantity of pink quartzite stone blocks from the Pipestone Central School demolition project. The purpose of salvaging the stone is to make it available for potential use for a local historical sign, public memorial, and repairs to a quartzite building(s) either in the City or County of Pipestone. Stone will not be available for purchase by the general public. The stone will be stored at a location within the City of Pipestone and any access to that location to obtain a quantity of stone will be granted only upon mutual agreement between the City of Pipestone and County of Pipestone. The demolition contractor shall deliver the stone to the designated location at his expense. The Pipestone City Administrator and County Administrator will be the primary contacts for the proposed uses of the stone. Requests for stone will be reviewed jointly by the Administrators and permitted only by mutual agreement of the parties. No stone will be allowed to be taken unless approved by both the City Administrator and County Administrator. Motion by Wildermuth, seconded by Kooiman to approve the agreement Between the City of Pipestone and County of Pipestone Regarding the Storage and Use of Reclaimed Pink Quartzite Stone Blocks. Motion carried unanimously.

## CENTRAL SCHOOL LEAK SITE INVESTIGATION

County Administrator Steve Ewing reported that there was a petro leak found at the Central School Demo Site in the boiler room. Bolton and Menk advised the MPCA. Quotes received for Leak Site Investigation Standard Scope of Work are as follows:
