The Pipestone County Commissioners met with Chairman Les Nath, Commissioners

Chris Hollingsworth, Luke Johnson, Bruce Kooiman, and Dan Wildermuth. Human Resources

Coordinator/ Interim Administrator Cathy Feste was also present. Chairman Nath called the

meeting to order at 9:00 AM with the Pledge of Allegiance to the Flag.

ELECTION OF BOARD CHAIR

AL OLSEN, CARING HANDS DENTAL CLINIC

Al Olsen, CEO of Caring Hands Dental Clinic, PCMC CEO Brad Burris, and PCMC CFO Dave Keeler joined the meeting. Olsen presented information on the Caring Hands Dental Clinic that he started to provide dental care to individuals without dental insurance in Minnesota. He currently has an outreach program that has performed services at Pipestone Public Health for the last two years. In the past year 400 patients were seen, which is only a fraction of the population that are in need of dental care. He is currently working with Pipestone County Medical Center to determine if a dental clinic could be placed in the hospital or build a dental clinic near the hospital and will be seeking bonding monies from the state legislature.

TRANSPORTATION PROJECTS WEBSITE PUBLICATION

Motion by Johnson, seconded by Nath to approve as per Minn. Statute § 311A.12 Subd. 2, that allows a county to use its web-site or recognized industry trade journals as an alternative to disseminate solicitations of bids, requests for information and requests for proposals and that the County of Pipestone may use the Pipestone County website, www.pipestone-county.com, as an alternative means to disseminate solicitations of bids, requests for information, and requests for proposals for transportation related construction and maintenance projects and that after designating publication on the Web site for transportation projects, the political subdivision must publish, in a qualified newspaper in the jurisdiction and on the Web site, notice that the political subdivision will publish any advertisements for bids on its Web site. Motion carried unanimously.

<u>UTILITY SETBACK ORDINANCE PUBLIC HEARING - 10:00AM</u>

County Engineer Dave Halbersma presented background information on the utility setback ordinance.

Chairman Wildermuth opened the Pipestone County Utility Setback Ordinance Public
Hearing at 10:01a.m. to consider the following amendment to the Essential Service Ordinance.

Any essential service line, essential service structure, or utility facility proposed to be installed within 100 feet of the road centerline of a County maintained roadway in Pipestone County, shall first have the written approval of the County Engineer or written approval of the Pipestone County Board prior to installation.

Hearing no public comment, Chairman Wildermuth closed the public hearing at 10:03 a.m.

Motion by Kooiman, seconded by Hollingsworth to approve the amendment to the Essential Service Ordinance to add the following language:

Any essential service line, essential service structure, or utility facility proposed to be installed within 100 feet of the road centerline of a County maintained roadway in Pipestone County, shall first have the written approval of the County Engineer or written approval of the Pipestone County Board prior to installation. Motion carried unanimously.

PLANNING/ZONING COMMISSION PER DIEM DATE

Consensus of the Board to set the Planning and Zoning Commissioner Per Diem Rate at \$100 per day to match the County Board's per diem rate.

<u>NEXTERA ENERGY RESOURCES – LAKE BENTON II REPOWER PROJECT</u>

Kimberley Dickey of NextEra Energy Resources and three of her team members presented information and went over the map of the Lake Benton II project. There are currently 137 turbines generating 102.8 megawatts that have been in operation since 1999. Beginning in 2019 there will be 44 modern turbines generating 100.2 megawatts. A request was presented to clarify with Project Director Denell Herzig if Pipestone County intended to be more restrictive on prevailing wind language than the Minnesota Public Utilities Commission ("Commission") who issues the site permit due to the size of the project.

Motion by Johnson, seconded by Hollingsworth to approve sending a letter to Denell Herzig of Lake Benton Power Partners, II in which Pipestone County would like to clarify that it was not our intent to be more restrictive than the Commission's requirements pertaining to the 3 RD and 5RD prevailing wind language. Furthermore, Pipestone County did not intend to regulate all type III, IV, and V wetlands but rather only those Public Water Wetland types III, IV, and V which are 10 acres or greater. Motion carried unanimously.

PERSONNEL

Human Resources Coordinator Cathy Feste requested the Board approve the offer of the County Administrator position to Steve Ewing at Step B of the 2018 pay plan. Motion by Wildermuth, seconded by Nath to offer Steve Ewing the position of County Administrator at Step B of the current pay plan and keep his Emergency Management duties. Yeas: Hollingsworth, Kooiman, Nath, Wildermuth. Nay: Johnson. Motion carried.
