LEGISLATIVE LETTER

INDIGENOUS DAY / COLUMBUS DAY DESIGNATION

County Attorney Damain Sandy joined the meeting to review his findings on whether or not the County board has the authority to declare an Indigenous People Day and/or designate Columbus Day as Indigenous People Day. Attorney Sandy stated that while the County Board cannot change a Federal holiday, they would have the authority to establish an annual day of local observation. Consensus of the Board to get more input from other counties Statewide to see if any of them have established Indigenous Peoples Day as a local day of observation.

SOCIAL HOST ORDINANCE

Pipestone County Coalition Alcohol Prevention Coordinator Steve Beekman joined the meeting. County Attorney Damain Sandy reviewed his comments on a proposed social host ordinance that would put responsibility on property owners that have knowledge of underage drinking and use of illegal substances on their property. Sandy stated that while there are already laws that address this for minors, this would also include 18, 19, and 20-year olds. Sheriff Vreeman voiced his support of the ordinance. Consensus of the Board to continue to work on the social host ordinance through the Law Enforcement Liaison Committee and review a new draft at a later date.

Motion by Johnson, seconded by Hollingsworth to adjourn. Motion carried unanimously. Meeting adjourned at 9:53a.m.
