LOCAL OPTION DISASTER ABATEMENT

Auditor Tyler Reisch presented an abatement request on Jason and Chinelle Christensen's homestead, located at 810 5th St, SW in Pipestone, which was destroyed by a fire on April 21, 2018. Minnesota Statute 273.1235 (Local Option Disaster Credit) states that the County Board may approve an abatement for any individual who has lost substantial value due to a disaster. The abatement will adjust the tax value, so all taxing authorities will see a decrease in distributed taxes. However, taxing authorities are allowed to levy the abated amount the year following the abatement. The pro-rated abatement is estimated to be \$1,371.47. Motion by Hollingsworth, seconded by Johnson to approve the tax abatement on the Christensen property located at 810 5th St SW in Pipestone. Motion carried unanimously.

BEEF BARN DONATION

Motion by Nath, seconded by Kooiman to accept the second installment of a Beef Barn donation from First Bank and Trust in the amount of \$10,000.00. Motion carried unanimously.

COURTHOUSE STUCCO AND STEPS REPAIR
