RESOLUTION 59-10-19

Chief Deputy Mike Hamann presented a resolution for consideration in which Pipestone County would enter into Joint Powers Agreements with the State of Minnesota, Department of Public Safety, Bureau of Apprehension to utilize applicable state and federal laws to investigate and prosecute crimes committed against children and the criminal exploitation on children that is committed and/or facilitated by or through the use of computers. Motion by Wildermuth, seconded by Johnson to approve Resolution 59-10-19 Approving State of Minnesota Joint Powers Agreements with the County of Pipestone on behalf of its Sheriff regarding the Minnesota Internet Crimes Against Children Task Force (ICAC). Motion carried unanimously.

RESOLUTION 59-09-19

Engineer Nick Bergman requested board approval for Resolution 59-09-19 which requests a variance from standard for State Aid Operation for project number S.P. 059-090-001. Pipestone County is preparing plans for Indian Lakes Pedestrian/Bike Trail Phase 3 from 121st St to 9th St NW in Pipestone, MN and Minnesota Rules for State Aid Operation 9920.9995, Minimum Off-Road and Shared Use Path Standards, require a minimum shared used path design speed of 20 mph, and surface width of eight feet, and an existing bridge is only six feet wide, so this would request a variance for approval from the State of Minnesota.
