GIS PROPOSAL

Environmental Administrator Kyle Krier and IT Director Bill Folger joined the meeting to request board approval to expend funds on County GIS expansion and upgrades. Cost of the product and license upgrades from Environmental Systems Research Institute, Inc. (ESRI) is \$10,500.00 plus \$9,000.00 annual maintenance fees. Motion by Wildermuth, seconded by Nath to purchase the product and licenses from ESRI for \$10,500.00 plus ongoing maintenance fees of \$9,000.00 annually. Motion carried unanimously.

Environmental Administrator Krier requested approval of a proposal from ProWest and Associates in the amount of \$13,785.00, with costs not to exceed \$20,000.00. ProWest will assist in on-premise implementation of the GIS system countywide. Motion by Wildermuth, seconded by Kooiman to approve the contract between Pipestone County and ProWest and Associates for on-premise GIS implementation at a cost not to exceed \$20,000.00. Motion carried unanimously. Both the ESRI cost and the ProWest contract will be paid for with the Soil and Water Conservation District Riparian aid compliance fund.

HIGHWAY PROJECT LETTING DATES

Highway Engineer Nick Bergman requested the board set a letting date for the federally funded box culvert project 059-602-026 on CSAH 2. Motion by Nath, seconded by Kooiman to set a letting date of July 23, 2019 at 10:30a.m. for project SAP 059-602-026. Motion carried unanimously.

Engineer Bergman requested the board set a letting date for box culvert projects SAP 059-603-006 and SAP 059-599-097. Motion by Wildermuth, seconded by Kooiman to set a letting date of July 23, 2019 at 10:40 a.m. for projects 059-603-006 and SAP 059-599-097. Motion carried unanimously.

TAX ABATEMENT PUBLIC HEARING

Motion by Kooiman, seconded by Nath to schedule a public hearing at 10:00a.m. on June 25, 2019 for a proposed property tax abatement request from Robert and Stella Menning, pursuant to Minnesota Statute 469.1813 and 116J.993 through 116J.995 consisting of new home construction located in the Township of Osborne. Motion carried unanimously.

PERSONNEL

Human Resources Coordinator Cathy Feste requested approval to approve the Paramedic job classification as a B22 rating on the DBM scale. Motion by Johnson, seconded by Nath to approve the Paramedic job classification to B22 effective June 11, 2019. Motion carried unanimously.

HR Coordinator Feste requested approval to place Cole Nordmeyer on Step C of the B22 pay range as a Paramedic. Motion by Johnson, seconded by Kooiman to approve placing Paramedic Cole Nordmeyer on Step C of the B22 scale. Motion carried unanimously.

MEINDERS COMMUNITY LIBRARY LETTER OF RECOMMENDATION

County Administrator Steve Ewing reported that the Friends of the Library is submitting an application for the Meinders Community Library to receive a grant up to \$5,000. Motion by Nath, seconded by Wildermuth to approve a letter of recommendation from the County Commissioners to include with the application. Motion carried unanimously.

Dave Rettman of DRC Inc. joined the meeting to report on the progress of the demolition of Old Central School. Commissioners thanked Mr. Rettman for the update. No action was taken.
