County Administrator Steve Ewing was also present. Chairman Kooiman called the meeting to order at 9:00 AM with the Pledge of Allegiance to the Flag.

DITCH CLEANING QUOTES

County Administrator Steve Ewing presented two quotes for ditch cleaning of Judicial Ditch #1 for approximately 3,000 feet. Quotes received were as follows:

Double "D" Gravel - \$19,970.00

\$1,000.00 for 50' additional feet south of the 9th street bridge

A & C Excavating - \$25,000.00

The Ditch Committee is recommending approval of the Double "D" Gravel quote with the additional 50' of cleanout. Motion by Johnson, seconded by Hollingsworth to approve the quote from Double "D" Gravel to clean out 3,350 feet of ditch in the amount of \$20,970.00 to be paid out of the Ditch Fund. Motion carried unanimously.

Engineer Nick Bergman requested approval for final payment for SP 059-602-026. Motion by Johnson, seconded by Nath to approve final payment for SP 059-602-026 Federal box culvert job on CSAH 2 ½ mile east of CSAH 16 to Henning Construction, Inc. of Adrian, MN in the amount of \$4,362.12. Motion carried unanimously.

Engineer Nick Bergman requested approval for final payment for SAP 059-030-013 2020 seal coat project. Motion by Hollingsworth, seconded by Wildermuth to approve final payment in the amount of \$3,730.59 to Astech Corp from St. Cloud, MN. Motion carried unanimously.

Engineer Bergman requested approval to increase the gravel crushing contract quantity by 25%, which brings the new total cost to \$162,625.00. The original gravel crushing bid was \$130,100. Motion by Nath, seconded by Hollingsworth to approve the request to increase gravel crushing contract quantity by 25%. Motion carried unanimously.

SIGN TRUCK CHASSIS

Engineer Bergman stated that in May the board approved the order of a new Kenworth sign truck chassis for \$81,244.37. Since then, there have been several benefits noted to upgrade to a 9L engine truck instead of a 7L. Bids received for an upgraded truck were as follows:
