Engineer Bergman presented information on road designation swaps possibly giving up lower traffic gravel roads for state aid roads and possibly obtaining a state grant for county road 54 going through Ihlen that connects with county road 20 going to the Split Rock Creek State Park possibly obtaining state park funds, and also 4<sup>th</sup> Street in Edgerton. Swapping roads would

allow the county to use state aid funds for road work on higher traffic roads. More information will follow.

#### **PERSONNEL**

Administrator Ewing presented the Auditor/Treasurer pay plan recommendation as evaluated by Gallagher Benefits, the county's compensation consulting firm. Based on the job description and decision-making requirements the recommendation is to place the position on the county pay plan at a rating of D63. The pay range would be \$77,937.60 to \$105,185.60. Motion by Hollingsworth, seconded by Wildermuth to approve the recommended rating of D63 and the presented pay range. Yeas: Johnson, Roskamp, Hollingsworth, Wildermuth. Nay: None. Absent: Nath. Motion carried.

Administrator Ewing requested approval to advertise to fill a 24 hour per week Highway Accountant position that would be a job share with the current Highway Accountant Leslie Lueck. The position would have Leslie Lueck working 16 hours per week and the new person working 24 hours per week. Insurance would be paid under a 2/5 and 3/5 contribution and vacation and sick leave accruals would also be prorated. Motion by Roskamp, seconded by Wildermuth to approve the Highway Accountant job share proposal. Yeas: Johnson, Roskamp, Hollingsworth, Wildermuth. Nay: None. Absent: Nath. Motion carried.

### SECOND QUARTER BUDGET REPORT

Administrator Ewing presented the second quarter budget report through June 30, 2021.

Commissioners reviewed the report as presented. Each department is noted to be on track for 50% of yearly budget. Ambulance was noted to be over budget due to purchase of new ambulance earlier this year. However, funds were used out of the ambulance reserves. Fairgrounds was noted to be at a -92% due to a reimbursement from the fair board from past grant funds that have paid back to the county.
