HOMETOWN FIBER MAPPING REPORT

Hometown Fiber Sales Director Marlena Pfeiffer joined the meeting to present the findings and review of the broadband mapping study, and Pipestone County's current internet infrastructure. Pfeiffer presented recommendations and financing solutions for the potential fiber installation project.

Recommendation 1 would provide direct fiber to all parts of the county that don't have fiber and are struggling to meet demand or will be in the next 3 to 5 years:

Recommendation 2 would include only the rural areas of the County which don't have fiber currently:

ROI 14.6 years
Per Property Cost \$12,086.00

Pfeiffer indicated that Hometown Fiber anticipates that the county could receive \$8,012,993 in state and federal grants and recommends that the county sell 15-year revenue bonds to pay for the rest of the cost. Commissioners thanked Pfeiffer for the information and would like further clarification about the financing of the project before deciding on the proposal.
