Engineer Nick Bergman requested the board reset the bid opening date for 2023 box culverts – contract #2, projects SAP 059-599-124, SAP 059-599-126, SAP 059-599-127, SAP 059-599-128, SAP 059-599-129, and SAP 059-607-023. Motion by Johnson, seconded by Nagel to set the bid opening date for 2023 box culverts contract 2 for March 28, 2023 at 10:30a.m. Motion carried unanimously.

Engineer Bergman requested the board set a bid opening date for gravel crushing. The gravel contract is for crushing 40,000 cubic yards and will have a completion date of July 15,

2023. Motion by Nagel, seconded by Hollingsworth to set a bid opening date of March 28, 2023 at 10:30a.m. for the 2023 gravel crushing contract. Motion carried unanimously.

Engineer Bergman requested approval of the 2023 Falling Weight Deflectometer (FWD) testing from Braun Intertec at a cost of \$5,327.20. FWD Testing is done to determine the different strength factors of an existing road, and the bid received covers 18.5 miles. Motion by Roskamp, seconded by Johnson to approve the bid for 2023 FWD testing from Braun Intertec in the amount of \$5,327.20. Motion carried unanimously.

# RESOLUTION 59-10-23 AGENCY AGREEMENT FOR FEDERAL PARTICIPATION IN CONSTRUCTION

Motion by Johnson, seconded by Hollingsworth to approve Resolution 59-10-23 and the accompanying Agency Agreement for Federal Participation in Construction, which states that pursuant to Minnesota Stat. Sec. 161.36, the Commissioner of Transportation be appointed as Agent of Pipestone County to accept as its agent, federal aid funds which may be made available for eligible transportation related projects. Motion carried unanimously.

## **CIVIL 3D/AUTOCAD SOFTWARE PURCHASE**

Motion by Nagel, seconded by Roskamp to purchase an annual subscription of 2 seats of Civil 3D and 2 seats of AutoCAD LT for \$5,344.16 from DLT Solutions, LLC in the amount of \$5,344.16 to be paid as an Auditors Warrant. Motion carried unanimously.

## **LIGHT MAINTENANCE REPAIR**

Engineer Bergman reported that the security light at the corner of County Road 15 and Highway 23 isn't working, and it is the County's responsibility to repair since it is the line between the pole and the main line. Operating cost for the security light is \$75.00 per month. Consensus of the Board to get the line fixed after the ground thaws.

Consensus of the Board wait on bid approval due to the higher than expected quotes, direct Bergman to try to obtain a quote from Papik Motors in Luverne, MN, and bring quotes back to a future meeting for approval.

Engineer Bergman reported on Maintenance updates from the past month including several days of plowing and blowing snow, salting, and sanding. Bergman also reported on a future fuel system software upgrade.

# **HOME INITIATIVE TAX ABATEMENT PROGRAM**

Auditor/Treasurer Amanda Sandy and Senior Appraiser Chris McChesney joined the meeting. Auditor/Treasurer Sandy reviewed the number of properties that have qualified for the Pipestone County Home Initiative program since 2017 and the total tax amounts abated. Sandy reported that the program expired on December 31, 2022 and presented a revised policy for board consideration effective January 1, 2023 through December 31, 2025. Motion by Roskamp, seconded by Wildermuth to approve the Pipestone County Home Initiative policy effective January 1, 2023 through December 31, 2025. Commissioners raised concerns on some of the language in the policy and would like to seek clarification, such as what type of financial assistance would disqualify an applicant and what type of housing qualifies as single family. Motion by Wildermuth, seconded by Johnson to table the approval of the Pipestone County Home Initiative policy to the March 14, 2023 meeting and to assign Commissioner Wildermuth to work with Auditor/Treasurer Amanda Sandy and County Administrator Steve Ewing to clarify the identified policy language. Yeas: Hollingsworth, Johnson, Nagel, Wildermuth. Nay: Roskamp. Motion carried.

### **2023 PAY EQUITY REPORT**

Human Resources Coordinator Cathy Feste requested approval of the Pay Equity Report due to the State of Minnesota Management and Budget every three years. The report covers both Pipestone County and Pipestone County Medical Center. Motion by Johnson, seconded by Hollingsworth to approve the Pipestone County Pay Equity Report as required by Minnesota Statutes 471.991-471.999, and direct Coordinator Feste to submit the Report to Minnesota Management and Budget and authorize Board Chair signature. Motion carried unanimously. The pay equity report will be submitted by the end of the day on February 14, 2023.

Motion by Johnson, seconded by Hollingsworth to approve the appointment of Chris McChesney as the County Assessor effective April 10, 2023 and place on step E of the pay plan. Motion carried unanimously.

Motion by Nagel, seconded by Wildermuth to approve hiring the Extension

Administrative Support Specialist on Step F starting February 21, 2023 contingent on completion of all background requirements. Motion carried unanimously.

Motion by Roskamp, seconded by Hollingsworth to approve hiring a Highway Maintenance Worker on Step F effective March 1, 2023 contingent on completion of all background check requirements. Motion carried unanimously.

# **RESOLUTION 59-09-2023**

Motion by Hollingsworth, seconded by Roskamp to approve Resolution 59-09-23 which states that Pipestone County, a host county to Western Mental Health Center, supports Western Mental Health Center, Inc. to become a licensed rule 245G Chemical Dependency Provider, with the resolution to take effect immediately. Motion carried unanimously.

# NORTHLAND SECURITIES ENGAGEMENT LETTER

Eilertson, Managing Director of Northland Securities, in which they would serve as underwriter
in connection with the issuance of Taxable General Obligation Tax Abatement Bonds. These
bonds would be a financing option to complete the Countywide Fiber Optic Network Project.
