RECYCLING CONTRACT RENEWAL

Environmental Administrator Kyle Krier presented the revised contract from Van Dyke Sanitation for the Countywide Recycling Program. Van Dyke Sanitation and the Solid Waste Committee met to discuss the terms of the contract. The Pipestone County Recycling Collection Agreement duration is from January 1, 2024 through December 31, 2028. The County will pay the Contractor \$3.20 per municipal residential dwelling per month, \$6.50 per business container per month with weekly collection services, and \$3,675.00 for all sheds and roll off locations per month. Shed and roll off collection will be done on an as needed basis. Motion by Johnson, seconded by Roskamp to approve the Pipestone County Recycling Collection Agreement between Pipestone County and Van Dyke Sanitation, Inc. effective January 1, 2024 through December 31, 2028. Motion carried unanimously.

DEMOLITION LANDFILL INFORMATION

Environmental Administrator Kyle Krier reported that there have been revisions to the MPCA's Rule on Construction and Demolition (C & D) Landfills. If the proposed rule-making is successful, and the new Construction and Demolition rules are promulgated, then all owners of unlined C & D landfills in operation will be asked to decide within 6 months if they will;

- a. Close, or
- b. Establish a timeline to move toward a newly constructed lined facility.

There is a 12-County Regional Plan that is actively being discussed; including what to do about our current C & D waste system. Administrator Krier noted that it might be helpful to have a meeting with local haulers to be able to bring information to the Regional Planning meeting. Consensus of the Board to schedule a Solid Waste Committee meeting to meet with local haulers to hear their comments, concerns, and ideas.

FAIRGROUNDS OVERHEAD DOOR PURCHASE

Building and Grounds Maintenance Supervisor Wayne Drew presented a quote for installation of three new overhead doors at the Fairgrounds, one in the sheep barn, and two in the horse barn. the estimate from Midwest Overhead Door of Edgerton, MN for the 3 doors, installation and trim is \$9,274.98. Drew said the Fairgrounds received a grant that will pay for this project. Motion by Hollingsworth, seconded by Johnson to approve the quote from Midwest Overhead Door of Edgerton, MN for \$9,274.98. Motion carried unanimously.

Human Resources Coordinator Cathy Feste reported that Deputy Recorder Rachel Davids has updated her resignation date to July 3, 2023. Motion by Johnson, seconded by Nagel to accept Rachel Davids resignation effective July 3, 2023. Motion carried unanimously.
