This floodplain ordinance is adopted pursuant to the authorization and policies contained in Minnesota Statutes, Chapter 103F; Minnesota Rules, parts 6120.5000-6120.6200; the rules and regulations of the National Flood Insurance Program (NFIP) in 44 CFR 59-78; and the planning and zoning enabling legislation in Minnesota Statutes, Chapter 394. ### ROAD AND BRIDGE ITEMS

Engineer Bergman reported that Maintenance Supervisor Nate Stoel will be on leave for military duty and an Intermittent Maintenance Supervisor has been assigned. Information only, no board action taken.

Engineer Bergman reported Cole Mann has accepted the temporary Summer Engineering Technician position starting in May 2024. Mr. Mann is going to school for engineering. Motion by Johnson, seconded by Nagel to approve the temporary position as recommended. Motion carried unanimously.

Engineer Bergman reported on CSAH 17 project. He is planning on tiling the North one mile of the road versus the 6-mile length, unless they get good bid prices on the entire length. The Engineer Department will have test holes drilled to check for issues with the road base.

Engineer Bergman reported that the City of Woodstock would like to have paving done in conjunction with our county project. Consensus of the Board was to draw up an agreement for the project and for payment upon completion. Engineer Bergman will review the recent agreement verbiage with the city of Pipestone on their project as a template.

# TERRY NELSON, GENERAL MANAGER, WOODSTOCK COMMUNICATIONS

Mr. Terry Nelson from Woodstock Communications reported that Woodstock Communications was approved for the Hatfield area Fiber to the Home (FTTH) project.

Woodstock will invest \$2,150,576 including \$1,612,932 in state grant funds. The grant will be for a two-year term with the construction beginning on or about August 1, 2025. Pipestone County will provide \$268,822 in local match. There will be 116 total passes in the project area.
