Engineer Bergman presented a request to approve Right of Way Payments for Projects and authorize payment as Auditors Warrant.

Motion by Wildermuth, seconded by Hollingsworth to approve the presented Right of Way Payments and authorize payment as Auditors Warrant. Motion carried unanimously.

Engineer Bergman reported that MnDot will place a detour on CSAH 10 from Highway 75 to Highway 23 due to road work this summer on Highway 23, there will be no payment for use of county roads as haul roads. Information only, no board action taken.

Engineer Bergman reported that the Edgerton motor grader could cost approximately \$27,000 for repairs and should last another 10,000 to 12,000 hours. There is a possibility that the engine may require a total overhaul depending on the internal damages costing approximately \$60,000. The grader currently has approximately 6,500 hours of use time. Information only, no board action taken.

Engineer Bergman reported on the Stone Arch Bridge Project time capsule that may be found during the bridge work this summer. Bergman would prefer to re-install the existing time capsule and possibly add some additional items to it or donate the capsule to the museum. Approximate start date on the bridge projects is May 15, 2024. Information only, no board action taken.

Engineer Bergman presented a follow up Power Point slide show from the Annual Road and Bridge Public Meeting that was held in February. He reviewed dust control and paving CSAH 17 and dust control on CR 84 from the county gravel pit to the corner; a distance of one mile. Discussed adjusting the cost share for the dust control program on county-maintained gravel roadways using calcium chloride or magnesium chloride at farmsteads. Current cost is 50% up to \$250. Discussed paving CSAH 17 and it was noted that there are two other paved roads, CSAH 16 West and CSAH 18 to the East. Also, he presented possible future projects CSAH 1 widen, CSAH 2 widen narrow points, CSAH 4 regrade/pave, CSAH 8 widen, CSAH 10 regrade, CSAH 15 pave, CSAH 17 pave, CSAH 20 widen shoulder, CSAH 55 widen/pave, CSAH 56 widen. These projects will be in a 5 to 10-year window for work. Commissioners liked the idea of widening and paving CSAH 55, which is located West of the Pipestone Area School and would be from the intersection of CSAH 15/5 to Highway 30. Also discussed was CSAH 56/7th 8th Avenue SE adjacent to the Kwik Trip and South past the Pipestone Golf Course for future work. Engineer Bergman will bring back an updated Dust Control Agreement for board approval.

Engineer Bergman reported on the department staff shortage. The front office is short a part time accountant and there may be times that the office may be closed.

BRAD ODEGARD, MN DEPARTMENT OF CORRECTIONS

Mr. Brad Odegard presented the Pipestone and Murray Counties Comprehensive Plan for board review. He reported that Pipestone and Murray Counties are state operated probation departments. Pipestone and Murray pay for support staff in their offices and the Probation Agents are state employees. During the 2023 legislative session the state authorized additional payments to counties to pay for cost of agent supervision of persons in the counties that are in the probation program. Motion by Johnson, seconded by Wildermuth to approve the presented Pipestone/Murray Comprehensive Plan. Motion carried unanimously.

<u>COUNTY ASSESSOR, CHIRS MCCHESNEY, RECYCLING FEE/SOLID WASTE</u> <u>ASSESSMENT ABATEMENT</u>

Assessor McChesney presented a request to abate the recycling/solid waste assessment for the city of Ruthton on the former RTR School property. The school has been demolished, and the playground equipment is on the site. The abatement is for \$162.00 for taxes payable in 2024 and will be removed from the tax system for payable 2025. Motion by Hollingsworth, seconded by Johnson to approve the abatement as requested on parcel 19.400.0005, City of Ruthton. Motion carried unanimously.

CYBER INSURANCE COVERAGE POLICY

IT Director Bill Folger presented information on the purchase of cyber insurance for Pipestone County. The recommendation is to approve the purchase of \$3,000,000 of coverage from Coalition for an annual fee of \$9,400.34. The fee includes \$500 broker fee and taxes. Motion by Wildermuth, seconded by Nagel to approve the purchase. Motion carried unanimously.

NICK BERGMAN, HIGHWAY ENGINEER, BID OPENING

Engineer Nick Bergman and County Attorney Damain Sandy attended the meeting to open bids for CP 2024-17 Gravel Projects

Administrator Ewing reported that Hailey Tyng has been hired as full time Correctional Officer/Public Safety Telecommunicator at Step A effective April 22, 2024.

Motion by Johnson, seconded by Wildermuth to close the meeting at 11:07 am. Motion carried unanimously. Also present at the closed meeting: County Administrator, County Attorney, and Highway Engineer. Motion by Wildermuth, seconded by Hollingsworth to come out of closed session at 11:25 am. Motion carried unanimously.

INTERAGENCY ROCK/PIPESTONE FAMILY SERVICES COLLABORATIVE AGREEMENT

Administrator Ewing presented the agreement. This Agreement is made and entered into effective when executed and signed by all the parties hereto, by and between Southwest Health

and Human Services - Social Services, Southwest Health and Human Services - Public Health, Rock Nobles Community Corrections, Southwestern Mental Health, Independent School District No. 2184 (Luverne), Independent School District No. 671 (Hills-Beaver Creek), University of Minnesota Extension - Rock County & Pipestone County, Southwestern Minnesota Opportunity Council, Southwest Minnesota Private Industry Council, Rock County, Independent School District No.581 (Edgerton), Independent School District No. 2689 (Pipestone Area), Minnesota Department of Corrections, and Pipestone County, hereinafter or individually referred to as "Parties" or "Party".
